Financial Policy Statement
2022/23 School Year**

Dear Parents,

This is a statement concerning the Financial Policy of St. John's Lutheran Church Early Childhood Center.

Please read, print, sign and return a copy of this form to the School Administrative Center together with your Registration Form, New Authorization Form (even if you have one already on file) and Registration Fee (for current students, your registration fee will be withdrawn from your authorized account). Please print a copy for your own records. If you have any questions, please contact Mrs. Kathleen Leich, the School's Director, or Ms. Roseann Toscano, the School's Administrative Assistant.

Tuition is calculated at an annual rate and for your convenience is divided into ten equal monthly payments as follows:

2 Year Old Program:

Mon/Wed 2 Days Per Week Program is \$2,450 Annual/\$245 per payment (10 payments)

Tues/Thurs 2 Days Per Week Program is \$2,450 Annual/\$245 per payment (10 payments)

Fun Friday, 1 Day Per Week Program is \$1,050 Annual/\$105 per payment (10 payments)

3 Year Old Program:

Four Days Per Week Morning Program is \$4,650 Annual/\$465 per payment (10 payments)

Two Days Per Week Afternoon Program is \$2,450 Annual/\$245 per payment (10 payments)

Fun Friday, 1 Day Per Week Program is \$1,050 Annual/\$105 per payment (10 payments)

4 year Old Program:

Five Days Per Week Morning Program is \$5,250 Annual/\$525 per payment (10 payments)

Three Days Per Week Afternoon Program is \$3,650 Annual/\$365 per payment (10 payments)

Tuition payments are electronically withdrawn on the 1st or 15th as follows:

Payment #1 July 1, 2022

Payment #2 September 1st or 15th 2022

Payment #3 October 1st or 15th 2022

Payment #4 November 1st or 15th 2022

Payment #5 December 1st or 15th 2022

Payment #6 January 1st or 15th 2023

Payment #7 February 1st or 15th 2023

Payment #8 March 1st or 15th 2023

Payment #9 April 1st or 15th 2023

Payment #10 May 1st or 15th 2023

There will be a \$25 service fee if there are insufficient funds available when the electronic withdrawal is made.

In the event your child is absent from school, for any reason, tuition payments are still required as listed in the above schedule since school expenses continue during your child's absence. You are free, of course, to withdraw your child at any time.

If your child enters school after the school year begins, at the time of enrollment you must pay the non-refundable \$150 Registration Fee, Tuition Payment #1 and the Tuition Payment due the first of the month of entry.

Subsequent Tuition Payments are due according to the above schedule. If you withdraw your child during the school year, all Tuition Payments due through and including the first day of the month of withdrawal must be paid.

If school is closed due to circumstances beyond our control, i.e. a World Pandemic, parents are responsible for the entire tuition payment for the month in which school is closed. After the first month that school is closed, subsequent tuition payments will be suspended until school reopens. Parents will be given the choice to join our Live Remote Learning Platform, for a monthly fee of \$100.

Amendments to this Financial Policy must be submitted in writing.

It is understood that St. John's Early Childhood Center reserves the right to terminate this agreement at any time if these financial obligations are not met.
